Our office receives many inquires concerning the WHDR-500 (5 gallon) Aqua-Blue system. Since the introduction of UL300 produced the WHDR-450 (4.5 gallon) Aqua-Blue system cylinder many of you are asking if it is permissible to upgrade a WHDR-500 cylinder to a UL300 configuration by piping it like a WHDR-450 cylinder as defined in our UL (EX-3559) Instruction Manual, Part Number 87-AQBLIM-000, dated October 1995 guided by the UL300 test protocol. Kidde's answer to this question is "YES YOU CAN".

Kidde Fire Systems has reviewed this issue and encourages the UPGRADE of existing installed Kidde Aqua-Blue WHDR-500 cylinders. Upgrades will require that these systems be repiped and appliance nozzles be repositioned or replaced to comply with the applicable Instruction Manual. Once upgraded the WHDR-500 is a 8 Flow number cylinder. You MUST upgrade the entire system and it is NOT permissible to upgrade a single nozzle. This upgrade ONLY applies to INSTALLED WHDR-500 systems. Once a system has been upgraded, it is not permissible to revert back to the original design or to use this system cylinder in a pre-UL300 installation. All UPGRADED Aqua-Blue systems shall have affixed to the system cylinder a decal, see attached sample, advising the end-user, Authority Having Jurisdiction and insurance companies that the system has been upgraded to comply with UL300 coverages. As with all system installations, this UPGRADE of existing installed Kidde Aqua-Blue WHDR-500 systems, MUST be acceptable to the Authority Having Jurisdiction.
